**Dear colleagues!**

The international conference “**Europe and Asia-Pacific countries: Problems of Interaction**” will be held in Irkutsk from **September 30 to October 1, 2013**. It is suggested to focus on different aspects of cooperation between the European Union, Russia and Asia-Pacific states, to consider the evolution of integration processes in both regions, to analyze the role of Russia as a bridge between the East and the West, to discuss the problems of European identity and perception of the EU in the world.

The following sections will work within the conference:

- Interaction between the European Union and Asia-Pacific countries
- Integration models of the EU and Asia-Pacific in the comparison
- Russia and Siberia between the East and the West
- European identity in the context of the EU's relations with oriental countries
- Image of the European Union in Russia and in the world.

Russian and foreign researchers are invited to take part in the conference.

**The deadline for applications and paper proposals is June 1, 2013. Applications submitted after this date will be rejected.** The application should include your name, title, position, e-mail and presentation title. **The deadline for paper abstracts submission is September 1, 2013.** The organizing committee will select participants on the basis of the submitted abstracts. It is planned to publish the abstracts in a separate volume before the conference. **The deadline for paper submission is December 1, 2013.**

Russian is the working language of the conference. Simultaneous interpreting will be provided for foreign presenters.

**Conference participants from the EUCES partner universities will be reimbursed the costs of travel, accommodation and meals.** Other participants can request partial or full reimbursement of travel and accommodation expenses. In that case the organizing committee will make a decision about financial support it can offer participants no later than June 30, 2013. The organizing committee **can book accommodation** at Irkutsk hotels for all participants. Abstracts will be published free of charge.

## Appendix 1: Presentation abstract requirements

Presentation abstracts are submitted in electronic form (Microsoft Word or OpenOffice format). The file should have a standard extension (.rtf, .doc, .docx, .odt) and its title should be the English version of the author's name: **ivanov.doc** —for I.I. Ivanov.

The authors should meet the following requirements when formatting their presentation abstracts:

The abstracts should be thoroughly edited.

The following items are given in the beginning of the article, each in a new paragraph:

- number according to the Universal Decimal Classification (UDC) in the upper left corner,
- author's name and initials (in the centre),
- abstract title (in the centre in lowercase letters)

The text is typed in Microsoft Word or OpenOffice, font size 12, single spaced, all margins are 2 cm, justified, indentation 0.5 cm. Consecutive page numbering, starting from the first page, in the center at the bottom of the page. Abstracts should be no more than 3 pages.

Citations are given in square brackets after the quote. The reference number, volume and page are indicated, for instance: [1. V. 2. P. 25].

The list of references is located after the text and is separated from the main body by the blank line. References are numbered (starting from number one) and preceded by the word "Notes". They are listed in order of mentioning or citing in the text (not in alphabetical order!). There can be only one reference per number. The format of references must correspond to the Russian State Standard GOST 7.0.5–2008.

**- for articles:**

*Olabarri I.* Historie and Science /Memory and Myth: towards new relations between historical science and literature // 18 International Congress of Historical Sciences. Monreall, 1995.

In case the electronic document deviates significantly from what is recommended, the organizing committee reserves the right to edit (shorten) the text for publication or deny its publication altogether.
